

























The following terms of sale are fully accepted by the purchaser as the order is assigned

- 1. ATTACHMENT DATE This price list cancels and replaces all the previous ones, it is not an offer and it cannot be changed without notice. The prices are indicated in Euros VAT not included.
- 2 ACCEPTANCE The company undertakes each order subject to acceptance.
- 3. PRICES Supply always occurs according to the prices indicated in the House Lists and under the conditions in force when the order is confirmed. Prices do not include assembly, installation or any other performance. Finishes and measurements beyond standard production must be agreed in advance.
- 4. DELIVERY Delivery takes place with utmost care, according to stock availability and production possibilities. Any delivery term entered in the order confirmation is considered as merely indicative and not compulsory. Delivery terms will be suspended in case of accident or by force majeure. Penalties or liability for delayed delivery are not accepted.
- 5. COMPLAINTS Any disproportion between delivery and order confirmation, as well as any flaw in the supplied products, must be reported to the House, in written form, immediately after having received the supply and, in any case, within 3 days. The House declines any liability in case of incorrect installation or assembly of its products.
- 6. REPLACEMENTS Returned goods, unless they are authorized by the House, are not accepted. Any defective good recognized and replaced by the House must be returned immediately after the replacement.

If goods are not returned within 15 days from the replacement, the supplier will be compelled to its invoicing according to the price indicated on the current lists. Goods that are rendered in non-perfect conditions will be credited according to the percentage of the recoverable amount.

- 7. PAYMENTS For any delay on agreed payments, default interests will be charged.
- 8. RESERVED PROPERTY Any delivered good belongs to the company until its relative compensation is fully paid. In the case of payments by check, they will be considered fulfilled after the verification of its success.
- 9. COURT The place of performance of the obligations on the buyer corresponds to the registered seat of Belluno. Any controversy arising from the supplies will be attributed to exclusive jurisdiction of the Court of Belluno.
